What is iPROMs?

0

iPROMs is an innovative web-based platform designed to collect feedback from patients about the care and interventions they have received from healthcare providers.

Data is collected electronically through the completion of Patient Reported Outcome Measures (PROMs), and Patient Reported Experience Measures (PREMs).

iPROMs can manage automated follow-up processes for patients following discharge, identifying those at risk and alerting healthcare professionals supervising their care iPROMs streamlines the collection and analysis of large amounts of data from validated outcome measures, such as Oxford Scores and Friends & Family Tests, or unvalidated measures based on best practice guidelines. iPROMs is unique in combining clinical data with patient and staff feedback and information entered by healthcare professionals, to provide a rich picture of a patient's experience throughout their care pathway

The web-based software provides detailed results and statistics, allowing healthcare providers to improve the quality, safety and efficiency of the services they provide. It also allows them to demonstrate their expertise with evidence from their clinical practice.

Who is iPROMs for?

iPROMs is designed for doctors, private practices, NHS commissioners, NHS departments and hospitals looking to obtain a greater understanding of the outcomes they deliver to patients.

How does it work?

iPROMs allows healthcare professionals to create their own questionnaires and use validated tools such as Oxford Scores or best practice guidelines. Patients are then asked to fill out tailored PROMs and PREMs online, at home or in hospital.

iPROMs is optimised for use on touch screens and a variety of devices, including computers, tablets and phones. Data collected in these user-defined questionnaires is automatically analysed, producing detailed reports complete with figures, statistics and graphical representations.


These reports can be used to monitor the progress of individual patients, demonstrate skills and expertise, and support contractual arrangements with commissioners. Information can be used to attract new business and increase patient confidence.

Why do you need it?

Patients will be able to access a user-friendly application which allows them to track their progress over time.

Doctors will be given iPROMs Tickets to hand out to their patients, with simple written instructions explaining how to access the iPROMs website. iPROMs is web-based and can be accessed from any computer or device with an Internet connection, so patients can register and log in from home. Healthcare providers can add a link to their existing websites for patients to access iPROMs.

After self-registering and completing their first assessment, patients will be notified of future PROMs by text or email, at time points defined by you.

Once logged in to the iPROMs website, patients will be able to:

- Complete any pending assessments
- View their completed assessments
- Monitor their progress, by comparing their scores to benchmark scores from patients undergoing similar procedures
- Provide feedback on their doctor(s)
- Have the option to request contact with their doctor(s)
- Access healthcare news and information specific to their needs

Features of iPROMs



• Customised PROMs solution

iPROMs can be customised to fit your requirements. It collects data from validated or customised assessments. You can choose clinical and non-clinical questions specific to the services you provide.

• Patient driven

iPROMs is easy to set up and use, even for patients with little computer knowledge. We provide an iPROMs Ticket for doctors to give to each patient, with personalised instructionss for the first time they log in. Once you define how often the patient should be followed up, iPROMs sends email and text alerts to remind them when their next assessment is due.

iPROMs caters to all patients, so even those with no internet access can have their feedback added to your database from a barcoded paper form. You can also monitor your patients' health remotely – iPROMs can alert you via email or text if a patient's answers are of concern.

Paperless and instant

iPROMs will consolidate your entire patient feedback in seconds, avoiding piles of forms and questionnaires. Managing the data collection and analysis process is made simple with our ready-to-go solution, which is easily adapted to your practice.

• Automated follow-ups

iPROMs can be used to automate patient followup following discharge. A risk assessment tool can be embedded in the questions being asked, so a clinician can be alerted by email or text if the patient's responses suggest they might be at risk. This reduces the chances of complications and the need for unscheduled care.



• Support your staff during revalidation

The majority of licensed doctors will be revalidated by 2016. iPROMs supports your practice during this process, by providing an accurate picture of medical performance supported by evidence and feedback. It allows risk adjustment scores to be factored in, and can also be used as a log-book to record a doctor's workload.

The GMC defines safety, quality and communication as key areas of the revalidation process*. iPROMs can contribute directly to these, ensuring patient safety, responding to risks and keeping patients informed about the progress of their care.

• Access your data anywhere

iPROMs is a web-based solution, and your information will be stored securely on our cloud server, allowing you to access your patient records and data across several clinical practices, at any time, from any device.

• Automated data reports
